B2C Collection services

Our B2C actions are made in accordance to local regulations and within the requirements of personal data protection law.

We proceed B2C cases on behalf of financial, banking, insurance and medical institutions, as well as regarding debts of utilities and related services.

Our goal is to recover the debt without involving additional costs – successful negotiations with debtors allow to recover the debt in full without legal actions. However in certain cases we proceed litigation towards natural persons – in files where debtor is located and there are real possibilities of legal recovery.

B2B Collection services

We provide professional debt collection services against B2B debtors with no upfront fees in amicable stage. Our success fee is a percentage of the amount paid or returned in other way by a debtor, its height depends on the amount of detailed claim. The commission fee is due after the debtor pays off his obligation in full or in part.


We provide International Debt Collection in over 100 countries all over the world working together with our local collectors. Our actions include out-of-court negotiations, judicial actions, bailiff actions.
